The petition of Norman D. Davis, Dan L. Hallock, David L. Moake, Coyt T. Wilson, Max Hinds, A. H. Allison, J. W. Dickens, Ross Wilson, Robert Pender, Peter J. Tiemstra, Edward Sexton, Curtis Jackson and DeVoe H. Willard respectfully shows to the Court:

Petitioners desire to be incorporated and made a body corporate under the laws of this State under the name and style of AMERICAN PEANUT RESEARCH AND EDUCATION ASSOCIATION, INC. for a period of thirty-five (35) years, with full right of renewal as may be provided by law, with its principal office in Spalding County, Georgia, or in such other place within or without the State of Georgia as its Board of Directors may from time to time determine.

The object and purpose of said corporation is as follows:

(a) To provide a continuing means for the exchange of information, cooperative planning and periodic review of all phases of peanut research and extension

being carried on by State Research Divisions, Cooperative State Extension Services, the United States Department of Agriculture, the Commercial Peanut Industry and supporting service businesses; and

(b) To conduct said Association in such manner as to comply with Section 501(c) (3) of the United States Internal Revenue Code of 1954 and Acts amendatory thereto.

The corporation shall have the power and authority to accept gifts and contributions, whether made by will or otherwise, in any form of property, provided that the objects specified by the testator or donor are within the objects and purposes of the corporation.

The governing body shall be a Board of Trustees and shall be composed as provided in the By-laws of the corporation as such By-Laws may from time to time be adopted and amended by the membership. The initial Board of Trustees shall consist of the present directors of the (unincorporated) American Peanut Research and Education Association, each of whom shall continue to serve until the first annual meeting of the American Peanut Research and Education Association, Inc. and until their successors are elected and qualified.

The corporation, unless otherwise required by the terms of any contribution, shall have the power in its discretion to retain all contributions in the original form in which they may have been received, and also to buy, sell, exchange and otherwise deal in stocks, bonds,

real estate and any other forms of property at either public or private sale, without order of any court or other authority, to invest and reinvest any funds belonging to the corporation at any time in such securities and property, real and personal, as the Trustees in their sole discretion see fit, irrespective of whether such investments may not be legal investments for trust funds under the laws of Georgia.

The corporation is not organized for profit and shall have no capital stock. No part of the property of said corporation and no part of its net earnings shall ever at any time inure to the benefit of any private shareholder or individual.

The corporation shall have all other powers, privileges and immunities which may now or hereafter be vested in similar corporations under the laws of Georgia.

WHEREFORE, petitioners pray that they may be incorporated under the name and style aforesaid, with all the rights, privileges and immunities hereinabove set out, and such other rights, powers, privileges and immunities as are or may hereafter be conferred upon corporations of like character under the laws of Georgia.
